**T**he NMBA presents the Awards of Excellence event as an opportunity for NMBA members to be recognized for their success in the previous year and their support of the NMBA and the mortgage industry. #### ***Loan Officer Award***

The loan officer award recognizes loan officers of member companies for outstanding volume and number of closed mortgages. Member companies can participate by nominating your loan officers. Nominees will be ranked into one of the following categories. Nominees may also be nominated for the *Community Lender of the Year*. The award for *Top Producer of the Year* will automatically be awarded to the member with the highest sales volume in 2017.

#### **Award Categories**

- Gold – To be determined by Awards Committee
- Platinum – To be determined by Awards Committee
- Diamond – To be determined by Awards Committee
- Community Lender of the Year
- Top Producer of the Year

#### **Requirements for Award Nomination**

\*All Volume and Units must have been originated while residing in the Middle Tennessee Market and as an employee of an office or branch of a member company in the Middle Tennessee market.

\*Minimum volume is \$10,000,000 or 100 units of closed mortgages

\*Only Loan Originators employed by member companies of NMBA are eligible. Company must have been a NMBA member in 2017.

Nominations can only be considered if all the conditions below are met:

- Nominating manager and nominees must be NMBA members in good standing.
- Nominee must have attended 3 events in 2017/January 2018 — events can include the Awards of Excellence, luncheons, Play Day, or NMBA Bowling Cup.
- All membership dues for member organizations must be paid no later than January 31.
- All outstanding activity invoices by members must be paid no later than January 31.
- A completed nomination form and fee of \$95 per nomination must be paid in full no later than February 5, 2018.

**Validation of Production:**

Must be listed and signed by the Loan Officer and Branch Manager, Production Manager or management that is directly responsible for the management of the Loan Officer. They will sign certifying the volume, numbers and dates of production are correct.

***Mortgage Member Award Qualifications***

The 2017 & 2018 boards of the NMBA are announcing a new annual award for the most valuable Mortgage member as determined by the NMBA membership. The award is open to all members of Mortgage companies that meet the requirements noted below. The Mortgage member will be honored at the Annual Awards of Excellence Event.

The purpose of the Mortgage member award is to recognize a Mortgage member who has demonstrated outstanding service and support of our association and our industry. This award will be given at the discretion of the current board of directors in any given year and based on nominations from the membership.

**Requirements for Award Nomination**

- The nominee must be a current member of the NMBA in good standing.
- The nominee must have at least a 2-year history of partnering with the NMBA. The partnering can include attendance at events, volunteering, or financial support to the NMBA or other industry organizations. The award will be given to an individual – not a company, so it is acceptable if the individual has partnered with the NMBA while employed at different companies.
- 2018 company membership dues must be paid no later than January 31.

The award will be given to an individual – not a company, so it is acceptable if the individual has partnered with the NMBA while employed at different companies.
